#### **AAAHC International Awards First Accreditation**

AAAHC International awarded its first accreditation to the <u>Nova Dental Center</u>, San Jose, Costa Rica, on April 23, 2010.

"The goal of AAAHC is to improve the safety and quality of patient care. Our peer-based survey process and our comprehensive education programs make our accreditation unique, and enable us to work closely with

ambulatory centers to assess their services and assure they provide high-quality care," said John Burke, Executive Vice President and CEO of AAAHC. "AAAHC International was created to continue this mission in other countries, and ensure that individuals there, whether being native to that country or taking advantage of medical tourism opportunities, receive the high quality of care that all AAAHC-accredited organizations must maintain."

Approximately 95 percent of clients of the Nova Dental Center, a full-service dental clinic that specializes in cosmetic dentistry, are from the U.S., according to <u>Luis</u> <u>Obando, D.D.S.</u>

"The accreditation process was a lot of work to get everything together to meet the standards, but in the end it helped to improve our clinical and administrative processes," Obando said. Nova Dental received a three-year accreditation from AAAHC. The Accreditation Association launched its international accreditation program in Costa Rica, and other organizations in that country have begun the process toward AAAHC International accreditation. AAAHC will add accreditation for ambulatory organizations in other countries soon.

#### **Decreased Turnaround Time**

AAAHC has identified areas of improvement and made significant changes in response to customer feedback about the decision process turnaround time. Staff and surveyors are working hard to lower the amount of time, while continuing to work with the Accreditation Committee to ensure each report still undergoes the peer-review process.



#### Ask the Expert

## **Q.** My ASC is Medicare certified and we use a C-Arm; does CMS really require that a radiologist supervise radiological services?

**A.** Yes, CMS expects ASCs that provide any radiological services to meet the condition 416.49 Laboratory and Radiologic Services and more specifically, 416.49(b) Standard: Radiologic Services, which requires:

(2) Radiologic services must meet the hospital conditions of participation (CoPs) for radiologic services specified in 482.26 of the CoPs.



One of the requirements, 482.26(c) Standard: Personnel, requires:

A qualified full-time, part-time or consulting radiologist must supervise the ionizing radiology services and must interpret only those radiologic tests that are determined by the medical staff to require a radiologist's specialized knowledge. For purposes of this section, a radiologist is a doctor of medicine or osteopathy who is qualified by education and experience in radiology.

CMS interpretive guidelines reinforce that supervision of radiology services may only be performed by a radiologist who is a member of the medical staff. The radiologist that is privileged to supervise radiology services accepts the responsibility for the provision of such services. As a reminder, the radiologist can be full-time or part-time and does not necessarily have to be present all the time. The governing body must determine the requirements of the supervising radiologist. ASCs can seek a radiologist to add to the medical staff or, as noted specifically in the requirement, the ASC may choose to contract with a consulting radiologist.
